

Editorial

The Brazilian Journal of Latin American Studies, which has the joint coordination of IELA and Grupo de Pesquisa Organização & Práxis Libertadora, from UFRGS, presenting another edition, bringing relevant themes to the examination of Latin America.

To this issue we have the text of Plinio de Arruda Sampaio Junior, "The Brazil-US relationship: the myth of the independent foreign policy", which seeks to understand the brazilian foreign policy in the context of US imperial domination, eliminating the mythology created in Brazil under President Lula according to which the country inaugurated a new diplomatic phase, marked by independence and sovereignty. Then Luis Felipe Aires Magalhães, in the text "Haiti is here: Brazilian sub-imperialism and the Haitians in Santa Catarina - SC" reveals as follows in Haiti the historical validity of the "development of underdevelopment" in an economic and social formation dependent, and shows how it has consolidate a migrating tradition in the country. Gilberto Felisberto Vasconcellos, with its peculiar worth, presents the text "Selfdevelopment: alcohol's microdistilleries in Minas Gerais", which discusses the concept of selfdevelopment anchored in thinking about biomass, prepared by the physicist Bautista Vidal. Nildo Domingos Ouriques analyzes the serious consequences of Venezuela's economic policy that to keep the exchange control while it has an open capital account, in the text "Development policy and transition to socialism" revealing a strategic weakness of the Bolivarian government that ends up exhausting the energy of the Bolivarian democratic revolution.

The REBELA also features the work of **Angela Analia Garofali Patrón**, "Latin American integration: an interpretation from the Marxist theory of dependency", which seeks to contribute to the discussion about the integration of the continent currently underway. Then **André Felipe Vieira Necklaces**, **Larissa Oliveira Silva** and **Agnes Franceille Freitas** bring the article "Is the nacional cinema prejudiced? Reflections about (the power of) media, social representations and homosexuality", from which they question and analyze how the media, through the national cinema, deals with the issue of homosexuality and its representations.
