

## **Editorial**

Latin America is seething in this new climate of political crisis. The Latin American Pendulum now gives indications that moves to the right. And that is embodied not only in losses in Argentina or Venezuela, but also in reducing the transformer impetus in the other countries. Therefore it remains essential to think critically Latin America, as we have done with our magazine. In this new edition of the Brazilian Journal of Latin American Studies seek to point out the problems and challenges of the continent, always with critical texts and own thought.

We open with the text of **Joallan Cardim Rocha**, about the "10 years of the Evo Morales government: The "Indigenous Nationalism" in power"?" in which he discusses the decade of work of the first indigenous president in the history of Bolivia, most recently elected with 52% of the vote in December 2005. Then **Rubens Sawaya**, in the article "Inflation, Growth and Development: how neoclassical macroeconomics hinders development", discusses how the use of anti-inflationary orthodox policies has prevented adoption of both growth strategies development. The third text is the Mexican **José Carlos Valenzuela Feijóo**, "The Subversive of History", from which he asks for the sense to understand or misunderstand history.

The work of Maicon Cláudio da Silva and Lauro Mattei, "The transition from slave to free labor in Brazil: A process of primitive accumulation in a dependent economy", a study briefly reviews the economic structure of the country during the imperial period showing that the abolition of slavery did not cause any significant change. Milton Carlos Bragatti, in the text "Inflexion on cooperation in defense in South America? - Perspectives and limits for the Unasur and the CSD", which points out that the defense area was one of the most advanced in the context of Unasur, unveiling the challenges of regional integration.

Sara Possari dos Santos, Joana Darque Passos Lima Vergotti, Artur de Sousa Moret and Sinclair Mallet Guy Guerra, bring the text "Imperialist pratices and the amazonian oil", which aims to understand why the US install Amer-rods bases in America Latina.

To close, the REBELA publishes the work of Luiz Hebeche, "About Schumpeter: From metaphysics of the economy to the economy of the metaphysics - Parts 1 and 2", with

which he makes an exposition of some of the central concepts of the economic theory of Schumpeter and It shows the character of his critique of metaphysics.

In the field of reviews, we have the text of **Gilberto Felisberto Vasconcellos**, "The Rogério Sganzerla's language and the idiots of the soap opera", with which he seeks life memories, readings and images of the filmmaker from Santa Catarina, placing it in the dynamic Art and Brazilian letters. And the Chilean **Orlando Caputo** with **Graciela Galarce**, "The economic successes of Bolivia compared with Mexico and Chile", in which they seek to evaluate the economic successes of the Plurinational State of Bolivia from a comparison with countries that follow the neoliberal model.

In the photo shoot, **Elaine Tavares**, **Kuaray Mariano**, **Marlon Moreira** and **Rodrigo Siqueira** discuss "The Indians of that time - the III ENEI Images" with the presentation of recordings on the III National Meeting of Indigenous Students, held in Florianópolis, 28 September to 2 October 2015.
