We opened this issue with the article by Bernardo Salgado Rodrigues, “**The three political typologies of dependent development in Latin America: contributions to a contemporary debate**”, with which he seeks to formalize the main ideas of dependent development (cepalino, Marxist and associated). Then, Luiz Eduardo Pereira Fernandes brings the text “**The blood of the condor, by Jorge Sanjinés: a possible analogy about Hollywood imperialism**”, from which He proposes a rescue of the motivations and mechanisms that allowed the American economic cultural domination in the countries From Latin America. Ednael Macedo Felix and Fábio Freitas Schilling Marquesan aim to understand the implications of public policies to combat drought in the Brazilian semi-arid with the text “**Public policies to combat drought in the semi-arid and its implications for the anthropoc-**
